These plaintiffs then resold those finished products to consumers through plaintiffs' retail stores. The plaintiff Eastman Kodak Company designed digital cameras containing TFT-LCD panels and had those cameras manufactured by an original equipment manufacturer for sale to a variety of consumers, including the retailer plaintiffs here.

The defendants are companies that manufactured and sold TFT-LCD panels. The defendants are AU Optronics or AUO, HannStar Display Corporation, LG Display, and Toshiba.

The plaintiffs allege that the defendants conspired to fix the prices of TFT-LCD panels. These are allegations and not evidence. The defendants have denied the plaintiffs' claims.
