The plaintiffs Best Buy, Target, Sears, Kmart, Newegg.com, Good Guys, RadioShack, and CompUSA are retailers who purchased finished products containing TFT -LCD panels, such as flat screen televisions, flat screen computer monitors, and laptop computers. These plaintiffs then resold those finished products to consumers through plaintiffs' retail stores. The plaintiff Eastman Kodak Company designed digital cameras containing TFT-LCD panels and had those cameras manufactured by an original equipment manufacturer for sale to a variety of consumers, including the retailer plaintiffs here.

The defendants are companies that manufactured and sold TFT-LCD panels. The defendants are AU Optronics or AUO, HannStar Display Corporation, LG Display, and Toshiba.

The plaintiffs allege that the defendants conspired to fix the prices of TFT-LCD panels. These are allegations and not evidence. The defendants have denied the plaintiffs' claims.
